Eleanor has also had extensive experience in criminal practice. She has been involved in criminal defence work on behalf of The Police Association in defence of members charged with serious criminal offences, officers giving evidence at coronial inquests and also appearing at the Office of

Police Integrity as well as private client defence work. She also has experience as a prosecutor undertaking prosecutions on behalf of the Department of Human Services under the Drugs, Poisons and Controlled Substances Act 1981. Eleanor also appears in the Coroner's Court where she is able to make use of Science degree in understanding medical and scientific evidence. Eleanor regularly appears as defence counsel in Occupational Health and Safety matters.
