Profile:

Sarah has expertise in criminal and public law. She appears in criminal trials, appeals, judicial review proceedings, commissions of inquiry and in regulatory cases. Her experience covers allegations of corruption, fraud, murder, conspiracy, anti-competitive conduct, workplace safety breaches and drug importation. Recently, Sarah appeared in the first criminal trial in the Federal Court, for charges of criminal cartel conduct including attempt to induce price fixing and bid rigging.

Sarah frequently appears at IBAC, both as counsel assisting and for interested parties. In public hearings, she has acted for Jetstar, the Department of Education (DET) a former Secretary of the DET and was junior counsel assisting in IBAC's first ever public hearings, into PTV. Sarah has been engaged to conduct a substantial number of investigations within private and government

organisations, concerning complaints of conflicts of interest, bullying and sexual misconduct. She also appears in professional conduct matters at the VCAT, briefed for the Medical Board, Nursing and Midwifery Board and Psychology Board of Australia.

Sarah provides written advice to Government Departments and Statutory Authorities.

Sarah has been recognised annually in Doyles Guide as a recommended Criminal Law Junior Counsel in Victoria since 2017 and as a Workplace Health & Safety Law Junior Counsel since 2021.

Sarah is on the Criminal Trial Preferred Barrister List; has an Indictable Crime Certificate and teaches at the Victorian Bar Readers Course. She has also taught advocacy on a number of occasions on behalf of the Victorian Bar at the Legal Training Institute, PNG.

Prior to signing the Bar Roll Sarah was Associate to the Honourable Justice Curtain in the Supreme Court of Victoria.
