Elizabeth (Liz) King is a Melbourne-based public and administrative law and human rights barrister.

Elizabeth worked as a senior solicitor with the Department of Human Services, providing legal advice to Ministers' Offices and DHS program areas in a range of fields including Aged Care, Public and Mental Health and Disability Services.

While working for the Department, Elizabeth oversaw investigative/civil prosecutorial litigation in relation to legislative (quality of care) breaches in the provision of care in aged care supported residential services pursuant to the *Residential Supported Services Act* (Vic).

Elizabeth has also instructed in litigation pursuant to the *Crimes (Mental Impairment and Unfitness to be Tried) Act 1997*, the *Health Act 1958* and the *Drugs, Poisons and Controlled Substances Act 1981* and appeared on behalf of the Department in a number of matters.


Elizabeth also worked for 3 years as legal projects officer with the Australian Red Cross. She has taught at Monash University and Victoria University, lecturing in International Humanitarian Law and International Public Law respectively. Elizabeth has presented widely in a number of international and domestic research and policy forum on human rights, humanitarian law and therapeutic jurisprudence. She currently chairs the Human Rights Sub-Committee of the Law Institute of Victoria.
