#### **PROFILE**

He also has experience advising on coverage under life insurance policies, including total and permanent disability, income protection, accident, and trauma cover.

#### **Professional Liability and Medical Negligence**

Joel represents a wide range of professionals in civil and regulatory disputes, including allied health, architects, auditors/accountants, building professionals, doctors, financial advisers, insurance brokers, lawyers, valuers, and veterinarians. He is regularly instructed in a broad range of medical negligence claims, including delayed treatment, misdiagnosis, surgical errors, and failure to warn brought against hospitals, general practitioners, surgeons, and consultants.

#### **General Liability**
